Kernel Estimation and Bandwidth Matrix Selection for Multivariate Distribution Functions

Results from matrix algebra and analysis are used to minimize local and global L_2 criteria of kernel estimates of multivariate distribution functions. Under different matrix structures, optimal bandwidth matrices are derived and their selectors are shown to possess fast rates of convergence.
